  National frequency allocations are mainly the same as the international frequency allocations. However, only the following bands are different.
  - 50-54MHz: This band is allocated to the broadcasing service not to the amateur service.
  - 68-74.8MHz: This band is also allocated to the broadcasting service as well as the fixed and mobile services.
  - 75.4-87MHz: This band is also allocated to the broadcasting service as well as the fixed and mobile services.
  - 144-146MHz: This band is allocated to the amateur and amateur satellite services, but is not used.
  - 146-148MHz: This band is allocated to the fixed and mobile services.
  - 470-890MHz: This band is allocated to the fixed and mobile services provided not to cause harmful interference to the broadcasting service.
