Abstract:

This report contains the results of the Rapporteur's Group meeting on Question 9/2, which was held in Geneva on 19 and 20 May 1999.

1. Introduction

In addition to the ITU Focal Points and staff, the meeting was attended by three representatives from three different countries only (See Annex 1: List of participants).

2. Agenda

The Agenda (Document RGQ9/2/001) as proposed by the Rapporteur was accepted (See Annex 2).

3. Results of the meeting

The Rapporteur presented Document RGQ9/2/002 (See Annex 3) containing his proposals to the meeting. After careful consideration and discussions, the meeting decided to propose to the Rapporteur's Group meeting in September 1999 the following proposals for adoption:

- 3.1 <u>Guidelines for the selection of those Questions of particular interest to developing countries</u>
- 3.1.1 Questions relevant to maintenance
- 3.1.2 Questions relevant to the acquisition of propagation data
- 3.1.3 Questions relevant to spectrum management
- 3.1.4 Questions relevant to the protection of installations and equipment
- 3.1.5 Questions relevant to international telephone tariffs and accounting
- 3.1.6 Other additional Questions selected in the last cycle, tabulated in Document 2/022 of the Study Group 2 meeting of September 1998.
- 3.1.7 Relevant Questions emanating from ITU conferences

In tabulating those Questions by their parent Study Groups in the other two Sectors, the following additional guidelines should be used for finalizing this list:

a. drop any Question under treatment directly by either ITU-D Study Group 1 or 2, or by one of the BDT Focus Groups

b. drop any Question for which the ultimate result(s) is (are) recommendation(s) addressed to the industry for manufacturing

c. seek the views of relevant counsellors in the other two Sectors, in particular Dr. K. Hughes (representing the Radiocommunication Bureau) and Mr. P. Rosa (representing the Telecommunication Standardization Bureau) in the final selection of these Questions

- 3.1.8 Due to the limited number of participants to the Rapporteur's Group meeting, it is proposed that the meeting in September 1999 will finalize the list of Questions, taking into consideration the list appearing in Document 2/022 of last year and the guidelines agreed.
- 3.2 Listing of relevant recommendations

As agreed by the meeting of September 1998 for each Question, the relevant recommendations should be mentioned with their scopes, if available.

3.3 Listing of Handbooks, relevant Reports, Manuals and Supplements issued by the other two Sectors

It is proposed to prepare two independent lists to be attached to the annual progress report as follows:

- 3.3.1 Handbooks and relevant Reports of the Radiocommunication Sector with a list on the scope for each
- 3.3.2 A list of all relevant Manuals and Supplements of the Telecommunication Standardization Sector
- 3.3.3 To nominate a group of participants of the September 1999 meeting to help the Rapporteur in finalizing the two lists
- 3.4 <u>Technical arrays</u>

As regards this issue, the Rapporteur's Group proposes:

3.4.1 To drop those technical arrays which are handled by a special Question:

a. Digital, audio and video broadcasting with relative interactivity, being the subject of Question 11/2

b. Broadband transmission over existing copper wire loops, being the subject of Question 12/2

- 3.4.2 To update the technical material attached to the Report on Question 1/2 of the last study cycle:
 - a. The Geostationary, Non-Geostationary FSS and MSS system capabilities
 - b. Frequency Agile systems
 - c. Stratospheric telecommunication service
- 3.4.3 To add any additional technical array proposed by the September 1999 meeting
- 3.5 <u>Radio-amateur issues</u>
- 3.5.1 It is proposed to continue within Question 9/2 with the sub-group, headed by an Associate Rapporteur dealing with radio-amateur issues. The meeting proposed to continue with Mr. Larry Price, Secretary-General of IARU, as Associate Rapporteur for this issue chairing such a sub-group.
- 3.5.2 The meeting finalized the text for the draft new Recommendation on "Effective utilization of the amateur services in disaster mitigation and relief operations" (see Document 2/010(Rev.1) to be distributed at the meeting of Study Group 2, 6-10 September 1999). The Study Group meeting is invited to consider the adoption of this new recommendation.
- 3.5.3 The meeting received a proposal from IARU to develop a handbook on disaster communications, contained in Document RGQ9/2/003. The meeting welcomed this proposal and decided to transfer it for consideration and decision to the Rapporteur's Group meeting on Question 16/2 in September 1999 (see document 2/079 to be distributed at that meeting).
- 3.6 <u>Structure of the yearly progress report</u>

The meeting proposed the following structure of this report:

3.6.1 An introduction with concentration on the objectives of the Question

- 3.6.2 A radiocommunication chapter (Questions, Recommendations, Handbooks and relevant Reports)

- 3.7 Draft Agenda for the September 1999 meeting

The meeting formulated a draft Agenda (see the separate Agenda for the Rapporteur's Group meeting on Question 9/2).

4. Conclusions

Although the meeting was successful, but due to the limited number of participating Administrations and sector members, main decisions were not taken and the major results were proposals only. It is recommended that the Study Group set directives for a minimum number of Administrations and sector members to participate in a Rapporteur's Group meeting in order for such meeting to be convened.

TITLE: PROPOSAL FOR THE WORK ON QUESTION 9/2

The Study Group 2 meeting in September approved the proposal of the Rapporteur's meeting on Question 9/2 (see Document 2/REP/001 (Rev.1)) based on the text of Document 2/022. The decision of the Study Group is reflected in the following headings:

1. Review of Guidelines for the selection of Questions based on the following criteria:

- (a) Questions related to maintenance;
- (b) Acquisition of propagation data for tropical zones;
- (c) Protection of telecommunication installations and equipment;
- (d) International telephone tariffs and accounting;
- (e) drop any Question already under treatment by the development sector;
- (f) drop any Question which ultimate products are addressed to manufacturers;
- (g) select relevant Questions which are adopted by ITU Conferences (Radiocommunications, Development or Standardization). This to include also those emanated from Plenipotentiary Conferences based on clear analysis of their expected results;
- 2. Prepare the list of Questions for each sector separately, add to that the summary and/or scope of the corresponding Recommendations, if available
- 3. Prepare an independent list of Handbooks of the radiocommunication sector as an independent document (with some analysis and if needed add scope)
- 4. Prepare an independent list of Manuals and Supplements of the Standardization sector (with some analysis, to drop old ones, and if needed add scope)

- 5. Prepare a draft Recommendation on the effective utilisation of the amateur services in disaster mitigation and relief operations
- 6. Review those technology arrays of particular concern to developing countries
- 7. The output of this Question should be a yearly progress report
