Issues for Training

- Targeted courses e.g. for Conformity Assessment and Type Approval
- Training with hands-on experience in a lab e.g. working in an operational lab with experts
- Sponsored courses e.g. fully funded travel, accommodation and instruction
- Partially sponsored courses e.g. on site living expenses paid, but travel funds required
- Private sector for profit courses e.g. fully loaded fees including fees for instructors
- Company sponsored training dealing largely or exclusively with promotion of their technologies





ITU Human Capacity Building Program 1/2

- Carried out through:
 - regular ITU-D program activities
 - Special projects
 - > ITU Centres of Excellence
 - Internet training centres
 - On-request advisory and consulting services
- ITU Academy a BDT initiative
 - Delivered in cooperation with partners extensive cirriculum
 - Providing face-to-face and distance learning
 - Visit the ITU Academy portal at http://academy.itu.int/
- ITU Centres of Excellence
 - Provides regional focal points for training/education
 - Supported by donors and other partners
 - Operating in Africa, Americas, Arab States, Asia-Pacific, CIS countries, Caribbean and Europe
 - Now being merged into a global training network of shared resources





ITU Human Capacity Building Program 2/2

- ITU Internet Training Centres (ITCs)
 - Focus on creation and enhancement of ICT and related skills
 - BDT works through partnerships with university and training bodies to set up ITCs
 - Provides access to affordable quality training using faceto-face and distance learning
 - ITCs complement technical training with soft skills such as entrepreneurial skills to facilitate self employment

 - Participants' living expenses during their stay in Canada are generally paid for by the Institute.
