As you are aware, the World Telecommunications Development Conference (WTDC-2006) in Doha, Qatar, had agreed to and adopted regional initiatives for the various regions of the ITU. The Arab region approved an initiative on the development of an Arab regulatory framework/guidelines for ICT.

The initiative is based on the output of the ICT Formalisation Committee that was established by the Arab Council of ICT Ministers in the run up to the World Summit on the Information Society held in Geneva and Tunis. This initiative was agreed to by their Excellencies the Arab Ministers of ICT during their meeting in Tunis in June 2005.

As the success of this initiative requires the active participation of all stakeholders, I am convening a kick-off meeting with all the beneficiaries to finalise the implementation scheme and deliverables of the initiative.

At the kind invitation of the Telecommunications Regulatory Authority (TRA) of Bahrain, the present Chair of the Arab Regulators Network, the International Telecommunication Union (ITU) Telecommunication Development Bureau (BDT) has the pleasure to invite a high level representative of your organisation to attend this first meeting concerning the Arab Region Regulatory Harmonisation Initiative in **Manama, Bahrain, from 21-22 October 2007.**

The objective of the meeting is to present the initiative to the beneficiaries and obtain comments and inputs on its implementation scheme and proposed deliverables.
