Subject: RAG correspondence group on the ITU-R Strategic Plan for 2008 - 2011

Reference: Administrative Circular CA/154 of 17 January 2006

1 The 13th meeting of the Radiocommunication Advisory Group (RAG) (Geneva, 30 October-4 November 2005) prepared a report to address the issues related to the ITU-R part of the draft Strategic Plan for the 2008-2011 period, in accordance with the requests contained in Document RAG05-1/19. The report, which is contained in Annex 3 to the Summary of Conclusions of the 13th RAG meeting (see Administrative Circular CA/154), was submitted to the Council Working Group for the Elaboration of the Draft Strategic Plan.

2 Following the meeting of the Council Working Group for the Elaboration of the Draft Strategic Plan (Geneva, 30-31 January 2006), the Chairman of the RAG has decided to establish a correspondence group to review the ITU-R portion of the draft Strategic Plan for the 2008-2011 period as contained in Document WG-SP-FP-06/10 (<http://www.itu.int/osg/spu/stratplan/2006/draft-itu-strat-plan-2nd-meeting.pdf>), which is open for comments until 24 February 2006.
