Broadcasting services (Radiocommunication Study Group 6)

By Administrative Circular CAR/164 dated 15 December 2003, 2 draft new and 2 draft revised Recommendations were submitted for approval following the procedure of Resolution ITU-R 1-4 (§ 10.4.5).

The conditions governing the approval of these Recommendations were met on 15 March 2004. Seventeen administrations responded, fifteen in favour of approval of these Recommendations, but as regards the draft modification of Recommendation contained in Doc. 6/BL/13, the Administration of the Arab Republic of Egypt and the Administration of the Syrian Arab Republic expressed a reservation.

These Recommendations are therefore approved by the ITU. Annex 1 to this Circular provides the titles of the approved Recommendations, with the assigned numbers.

The texts of the approved Recommendations will be published by the ITU.
