Subject: Radiocommunication Study Group 6

- Adoption of 4 revised Recommendations and 7 new Recommendations by correspondence and their simultaneous approval in accordance with § 10.3 of Resolution ITU-R 1-4 (Procedure for the simultaneous adoption and approval by correspondence)

Broadcasting services

By Administrative Circular CAR/216 dated 10 April 2006, 4 draft revised Recommendations and 7 draft new Recommendations were submitted for simultaneous adoption and approval by correspondence (PSAA), following the procedure of Resolution ITU-R 1-4 (§ 10.3).

With the exception of the draft revision of Recommendation ITU-R BT.1203 contained in Document 6/280(Rev.1), the conditions governing this procedure were met on 10 July 2006, with seven Administrations responding in favour.

One Administration objected to the adoption of the draft revision of Rec. ITU-R BT.1203 in Document 6/280(Rev.1). In accordance with the provisions of Resolution ITU-R 1-4 and after consultation with the Study Group Chairman, the document will be sent back to the relevant Working Party for further review.

The approved Recommendations will be published by the ITU and Annex 1 to this Circular provides their titles, with the assigned numbers.
