Subject: Application of No.11.44.1 of the Radio Regulations (WRC-2000)

Dear Sir.

- 1. The Radiocommunication Bureau hereby draws the attention of all administrations to the provisions of No. 11.44.1, which entered into force on 1 January 2002, and the Rule of Procedure relating to Nos. 11.44 and 11.44.1, adopted by the Radio Regulations Board at its 24th meeting (Geneva, 10-18 September 2001).
- 2. These provisions stipulate that the assignments included in a request for coordination shall no longer be taken into account by the Bureau or administrations unless the first notice for recording of the assignments in question under No. 11.15 has been received by the Bureau by the end of the seven-year (or nine-year) regulatory period, as from the date of receipt or publication, as appropriate, of the relevant advance publication information.
- 3. In this context, the Bureau has prepared two lists of networks as follows. Annex 1 contains a list of networks, with an indication of their respective API publication date, for which a request for coordination has been received by the Bureau and for which the nine-year regulatory period will expire before 1 July 2003, but for which no notification information has yet been received by the Bureau. Annex 2 contains a list of networks for which a request for coordination has been received by the Bureau and for which the nine-year regulatory period will expire before 1 July 2003, but for which notification information, having been received, was returned to the administration as the result of an unfavourable finding.
- 4. The Bureau requests your Administration to kindly verify the attached lists and submit the notification information under No. 11.15, either with all the required agreements obtained (No. 11.32), or with certain agreements still missing, but with a request to apply the provisions of Nos. 11.32A, 11.35 or 11.41, as appropriate.
- 5. The attention of your Administration is drawn to the fact that the lists in the Annexes do not include networks for which notification information has been partly received and has been recorded, or is in the process of being recorded, in the MIFR. Your Administration is kindly requested to check whether any of its networks fall into the above category and to submit the notification information as mentioned in paragraph 4 above for the corresponding assignments still at the coordination stage and for which the nine-year regulatory period will expire before 1 July 2003.
- 6. Please note that this communication is to be considered as the Bureau's advance notice as referred to in No. 11.44.1.
- 7. The Bureau trusts that your Administration will provide the required information as indicated above. In the event that such notification information is not received within the specified period, the Bureau will initiate further action as foreseen by No. 11.44.1 and the related Rule of Procedure.
