Subject: Second meeting of SG 1 Rapporteur Group to revise the Handbook on Computer-Aided techniques for Spectrum Management

The Study Group 1, at its last meeting in November 6-7, 2003 decided to create a Rapporteur Group to revise the Handbook on Computer–Aided techniques for Spectrum Management, edition 1999. The Group will work according to the Terms of reference as contained in the SG 1 Decision [Doc. 1/17].


5. How to find LS telcom AG

Should you arrive by car, you have to take the motorway A5 (Autobahn), exit Bühl. Turn left to Oberbruch/Moos and follow the signs to Lichtenau/Ulm. Drive all the way through Ulm and Lichtenau (direction Kehl). Close to the city limits of Lichtenau there is a fuel station where you turn right towards the industrial area. Take the next turn left and left again. Follow the road and you will find LS telcom in a left bend on the right.

Should your arrive by train, the nearest station would be either Baden-Baden or Bühl/Baden.

When arriving by plane you have the choice between airport FKB Baden-Karlsruhe, airport FRA Frankfurt/Main, airport STR Stuttgart or airport Strasbourg-Entzheim.
