- ✓ **Credentials** (CV/328-331)  
If Credentials are not in order (CV/333), Member States are not entitled to exercise the right to vote or to sign the Final Acts until the situation has been rectified.
- ✓ **Transfer of powers** (CV/335)  
A Member State which is unable to send its own delegation may give the delegation of another Member State powers to vote and sign on its behalf.
- ✓ **Proxy vote** (CV/336)  
A delegation may give to another delegation a mandate to exercise its vote at one or more meetings.  
A delegation may not exercise more than one proxy vote (CV/337)

  - Final Acts at the end of WRC-12: one CD-ROM to each participant and one paper copy to the HoD or his/her designated representative.

# Guidelines for the preparation of Proposals

## Mandatory use of the 2008 Edition of the Radio Regulations

(at: <http://www.itu.int/publ/R-REG-RR-2008>)

Member States and Regional Groups should begin their proposals with a short summary of their views on each agenda item; followed by all detailed proposals; each proposal is followed by a brief statement of the reason for the proposal.

- **ADD** Addition of new text. **DO NOT UNDERLINE**
- **ADD\*** Addition of existing text from elsewhere in RR
- **MOD** Amendment of a text by addition, deletion or replacement, use track changes to show modifications
- **(MOD)** Amendment of a text, from an editorial point or view, use track changes to show modifications
- **SUP** Deletion of existing text
- **SUP\*** Transfer of text elsewhere in RR
- **NOC** Text for which no change is proposed
- **NOC** Text to be maintained without change (include a proposal number)
