### Singapore

*Maritime and Port Authority (MPA)* announces that it has implemented the Global Maritime Distress and Safety System (GMDSS). Its Port Operations Control Centre maintains distress watch-keeping on VHF DSC (channel 70), on MF DSC (2187.5 kHz) and on VHF (channel 16). Maritime Safety Information (MSI) is broadcast on VHF (channel 09) and NAVTEX. *Maritime and Port Authority* has ceased broadcast of MSI on 516, 4322, 4369 kHz and SafetyNET.
