## Colombia (country code +57)

Communication of 3.IV.2002:

The *Ministerio de Comunicaciones*, Bogotá, D.C., in collaboration with the Telecommunication Regulatory Commission, pronounced the Decree 25 of 11 January 2002 that adopts the National Numbering Plan (NNP) and the Migration Plan that specifies the procedures for its introduction. The non-geographical numbering change will start as from 1 June 2002 and the numbering changes and their new dialling procedures are described below.

- Non-geographical numbering plan  
 International Number Structure

The International Number is twelve digits in length, composed of:

Country Code (CC) (two digits) + National Destination Code (NDC) (three digits) + Subscriber Number (SN) (seven digits)

The numbering is classified in several categories according to the service provided:

Type of numbering	NDC categories
Geographic numbering	Geographic regions
Non-geographic numbering	Networks UPT Services

The networks include the cellular mobile network, PCS and satellite mobiles, among others. The NDC of the mobile network in the former plan was the digit 3. In the new plan, it increases by two digits and is divided into two different NDC (one for Network A and the other for Network B). The numbering of the freephone service, with ten digits structured 9800123456, migrates to 8000123456. The following table resumes the previous and new non-geographic NDC.

The new numbering plan implies the addition of two digits in the non-geographic NDC numbering, as from 1 June 2002. The change in geographic numbering is planned for the month of April 2004 and information will be provided on this in due time.

The non-geographic NDC change to three digits, the geographic NDC remain with one digit until the next phase of the migration in 2004. The mobile NDC, currently defined, are 310 for Network A and 315 for Network B. The NDC that are currently defined are 800, 900 and 947. For future PCS operators, the NDC will be 300.
