Global Symposium for Regulators, Nassau, Bahamas, 11 -14 July 2017**

Dear Sir/Madam,

I am pleased to invite you to participate in the annual meeting of Regulatory Associations that will precede the **Global Symposium for Regulators 2017 (GSR-17)**. This meeting will take place in Nassau, Bahamas, in the morning of 12 July 2017, from 09:00 AM until 12:00 PM, and will be organized by the International Telecommunication Union (ITU) in collaboration with the Utilities Regulation and Competition Authority of the Bahamas (URCA).

Participation in the event is by invitation only as the event is reserved for Regional Regulatory Associations, in particular the Head of the Secretariat and the Chairs, or a duly appointed representative. The Regulatory Associations meeting provides an opportunity to discuss, exchange information and build bridges towards better and more active cooperation between the Regulatory Associations in the various regions.

The topic for discussion this year will focus on the role of regional and international organizations in achieving affordable access to ICTs, addressing in particular Universal Access and Service Strategies in a collaborative regulatory environment, and International Mobile Roaming. Participants will also be granted the opportunity to present their activities, in particular in terms of exchanging relevant information with other Regional Regulatory and International Organizations. A summary of discussions will be included in relevant panels at GSR-17.

You are also invited to participate in GSR-17. This year, the theme will be "Living in a World of Digital Opportunities." The draft Agenda for GSR-17 (available [here](#)) has been built carefully taking into account the input from GSR-16, the chief Regulatory Officers Meeting and inputs that were sent to us later. On 11 July, the Global Dialogue on Digital Financial Inclusion will be held as a pre-event to GSR-17, focusing this year on the security of digital financial services.
