The plan will also produce social benefits including a reduction in the gender gap in terms of access.

This forum will address topics of importance for the development of telecommunications. We are here to bring about an exchange of experience, expertise and good practice, to use the opportunity for dialogue and debate on these important topics and create a more conducive environment for the development of telecommunications in our countries, tackling the major challenge of the digital divide and ensuring that our peoples benefit from the opportunities offered by telecommunications.

I hope very much that this forum will be beneficial and productive.

And let us not lose sight of the fact that we are here for the sake of people, our people. I wish those of you who are visiting our country a very pleasant stay with us and hope you enjoy our warm climate and the warm hospitality of the Paraguayan people, who welcome you here with open arms and thank you for your visit.
