6. VISA procedure

4. Security

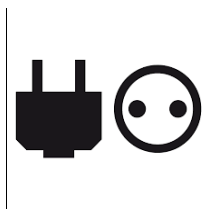
The crime rate in Tunisia is medium on UNDSS security advisory.

However, visitors are advised to observe common safety practices while travelling (e.g. storing valuables in safe, keeping wallets in a secure pocket, etc.).

For any security incident, visitors should contact the police on 197.

AC power voltage in Tunisia is 220V, frequency ~50Hz. Most electrical outlets are as shown below:



6. Services available for participants during the workshop

Internet Wireless:

Access to Internet wireless will be available during the event.

Translation English/French:

Only for the presentation (on the first day: 23 May 2016) and not for the Cyberdrill.

Security:
