Background

From 12 to 14 November 2014, the participants in the Accessible Americas: Information and Communication for ALL regional conference, held in Sao Paulo, Brazil, shared challenges and best practices for promoting ICT accessibility. As a result of the discussions facilitated by ITU, which put together regional governments representatives, intergovernmental agencies, regional organizations, civil society, organizations representing persons with disabilities and the private sector, it was developed a set of guidelines including principles and actions needed to support implementation of ICT accessibility in the Americas Region, aiming at encouraging all relevant stakeholders to become leaders in promoting ICT accessibility within their respective working areas.

During the following regional meeting on ICT accessibility, held in Medellín, Colombia, from 4 to 6 November 2015, presented a milestone opportunity to deepen the regional commitment towards removing barriers faced by persons with disabilities and achieving an inclusive society through the development of concrete actions and changes on the ground, and the mainstreaming of accessible ICT in the regional telecommunication agenda framework.

In November 2016 "Accessible Americas III" was hosted in Mexico City, Mexico, from 28 to 30 November 2016, at the kind invitation of the Telecommunication Federal Institute (IFT). The event focused on the importance of promoting accessibility policies; motivating policymakers of these policies, regulators, industry and academia; and encouraging all the stakeholders concerned to work together with PwD in the expansion and inclusion of accessibility in all processes: legal framework; public access to ICTs; movable communications; television and video programming accessibility; web accessibility, mobile telephony, and public procurement of accessible ICTs. As a result, a compilation of "Good Practices and achievements in ICT Accessibility in the Americas Region" was prepared with the inputs attained from the questionnaire circulated in early 2016 and contributions from the participants of the event.

The number of contributions received in response to the questionnaire in 2016 was far short of our expectations and we would like to have a relevant increase in the number of contributions in 2017 as to allow us to present in Costa Rica a more realistic scenario in terms of good practices and achievements in ICT accessibility in the Americas. The results of initiatives and projects already successfully implemented must be shared and can be valuable to many others that have not yet achieved desired goals.

To this end, "Accessible Americas IV", which will be hosted in San José, Costa Rica, from 15 to 17 November 2017, at the kind invitation of the Costa Rican regulator, Superintendencia de Telecomunicaciones (SUTEL), will reinforce the importance of the work of stakeholders in ensuring ICT accessibility for all and will continue to divulge ITU willingness to assist its Members in preparing and implementing ICT accessibility policies and strategies and provide suitable training.

The present questionnaire form is intended to collect inputs from all relevant stakeholders and thus, not only to enable them to share their challenges and experiences but also to contribute to a

The questions are almost the same of the questionnaire shared in 2015 and 2016 and we hope that the number of contributions significantly increases in 2017 as to allow us to present in Costa Rica a more precise scenario in terms of the developments and advances achieved. In case the Regional Initiative proposed by the countries of the region during the preparatory meeting for the World Conference (WTDC-17), held in Asunción, in February 2017, is confirmed during the WTDC-17, the contributions of the questionnaire may serve as reference to the work of the ITU for the period 2018-2021.
