I am pleased to inform you that the International Telecommunication Union (ITU), in collaboration with the Ministry of Communications and Information Society of Romania and the National Authority for Management and Regulation in Communications of Romania (ANCOM) is organizing a Regional Workshop for Europe and CIS on "Spectrum Management and Transition to Digital Terrestrial Television Broadcasting" to be held from 21 to 23 March 2016 in Bucharest, Romania.
