Implementation of Resolution 908 (Rev.WRC-15) – Availability of a trial version of the application "e-Submission of Satellite Network Filings"

The Radiocommunication Bureau is pleased to inform the ITU-R membership of the publication of Circular Letter CR/427 *Implementation of Resolution 908 (Rev.WRC-15) – Availability of a trial version of the application "e-Submission of Satellite Network Filings*" on 13 March 2018. This Circular Letter announces that the online application "e-Submission of Satellite Network Filings" is now available for beta testing by administrations and operating agencies until 1st June 2018.

This application has been developed in response to Resolution **908** (Rev.WRC-15) to allow administrations to submit their satellite network filings or their comments related to a BR IFIC through an online interface without the need for emails or faxes. This online application encompasses all types of submissions related to satellite networks or systems as well as to earth stations and radio astronomy stations.

As indicated in CR/427, prior to using the system, it is required that every Administration designates a Manager to manage all accounts within his/her Administration. Then, this Administration Manager will be able to log in and to add other users either from the Administration or its Operators.

Availability of a trial version of the application "Satellite Interference Reporting and Resolution System" (SIRRS)

This Circular Letter announces that this online application is now available for beta testing by administrations and operating agencies until 1st June 2018.

This application has been developed in response to Resolution 186 (BUSAN, 2014) and in line with Annex 2 to Decision 5 (REV. BUSAN, 2014) on modern electronic communication methods. The objective of this system, as reported to WRC-15, is to facilitate the communication between the parties concerned in case of harmful interference and to assist them in the identification of sources of interference and their prompt elimination in accordance with the provisions of Article **15** and No. **13.2** of the Radio Regulations. The system allows to capture information in accordance with Appendix **10** of the Radio Regulations and to upload additional information in the format of Report ITU-R SM.2181, Recommendation ITU-R RS.2106-0 or any other standard format.

As indicated in CR/428, prior to using the system, it is required that every Administration designates a Manager to manage all accounts within his/her Administration. Then, this Administration Manager will be able to log in and to add other users either from the Administration or its Operators.
