

## RESOLUTION 35 (REV. WRC-23) – SPACE NETWORK LIST - EXPLANATION

### 1- Introduction

The webpage displays the list of all satellite systems notified to the Bureau, published in PART I-S, PART II-S, PART III-S of the BRIFIC and subject to Resolution **35 (REV. WRC-23)**.

For each of these satellite systems, the table displays the status related to the different milestones defined in the Resolution **35 (REV. WRC-23)**.

### 2- Explanation of the table

Titles of the column	Explanation
Satellite name	Name of the satellite system
ADM	Country symbol of the notifying administration
IGSO	Symbol of the organization operating regional or international satellite networks
7-year limit / 01.01.2021	The end of seven-year regulatory period specified in No. <b>11.44</b> or the date 01.01.2021 if the regulatory period is earlier than this date.
M0	Status related to the Milestone 0 (initial deployment)
M1	Status related to the Milestone 1
M2	Status related to the Milestone 2
M3	Status related to the Milestone 3
Resolve 19	Information related to <i>Resolve</i> 19 of Resolution <b>35 (REV. WRC-23)</b>
No. of notified space stations	Total number of space station notified in the satellite systems (irrelevant of the frequency bands)
No. of deployed space stations	Total number of space station deployed (irrelevant of the frequency bands). This number is displayed after the publication of the RES35 submission.

The status in column M0, M1, M2 and M3 are displays as follows and is linked to the publication if available:

Date of the milestone (DD.MM.YYYY)	in case the submission has not yet been received for this milestone.
As Received	in case the submission has been received but not yet published by the Bureau in a BRIFIC. It provides a link to the As received page.
Met	in case the submission has been published by the Bureau in a BRIFIC and the milestone requirements have been met.
Not Met, resolves 12 applies	in case the submission has been published by the Bureau in a BRIFIC and the milestone requirements have not been met but the Radio Regulations Board gave a favourable determination under resolves 12 of Resolution <b>35 (REV. WRC-23)</b> , thus waiving the need to meet the requirements for the first milestone under <i>resolves</i> 7a)/11a).
Not Met	in case the submission has been published by the Bureau in a BRIFIC and the milestone requirements have not been met.

The value in the column Resolve 19, if any, is the date from which, for a satellite system which has completed the milestone process, the number of deployed satellites falls below 95% of the total number of satellites indicated in the Master Register. The notifying administration should provide this information in accordance with *Resolve* 19 of Resolution **35 (REV. WRC-23)**.
