What is SpaceCom software?



- An application to assist Administrations in the management of their objections (comments) to networks published in certain Special Sections concerning certain types of coordination / agreement seeking procedure
- *Resolution 55: comments/objections/requests for inclusion or exclusion submitted to the Bureau for various procedures shall be submitted in electronic format compatible with the BR electronic notice form capture software (SpaceCom)*



Operation of SpaceCom – General overview



- 1. Select commenting procedures**
- 2. Enter your administration**
 1. One time operation, will have to re-install if you wish to change administration
- 3. Enter the IFIC number that you wish to comment on**
- 4. Select the appropriate IFICXXX.mdb file**
- 5. SpaceCom will list the satellite networks published in that IFIC that are subject to the commenting procedure that you have selected in 1)**
- 6. Capture of comments for specific satellite network**
- 7. Validation tool to check whether mdb comment file has been completed**
- 8. Submit the completed comments file to BRMAIL@ITU.INT**



Submission of comments to Bureau



SpaceCom Comments to a special section should be submitted **within 4 months from date of publication**



Change the file extension from “.mdb” to “.itu” to prevent the file from being deleted by email servers.



NOTE: *SpaceCom V8 only works on V8 database*

Therefore, to submit comments up till IFIC 2835 / 20.12.2016, SpaceCom V7 must be used!

After that, only SpaceCom V8 should be used.

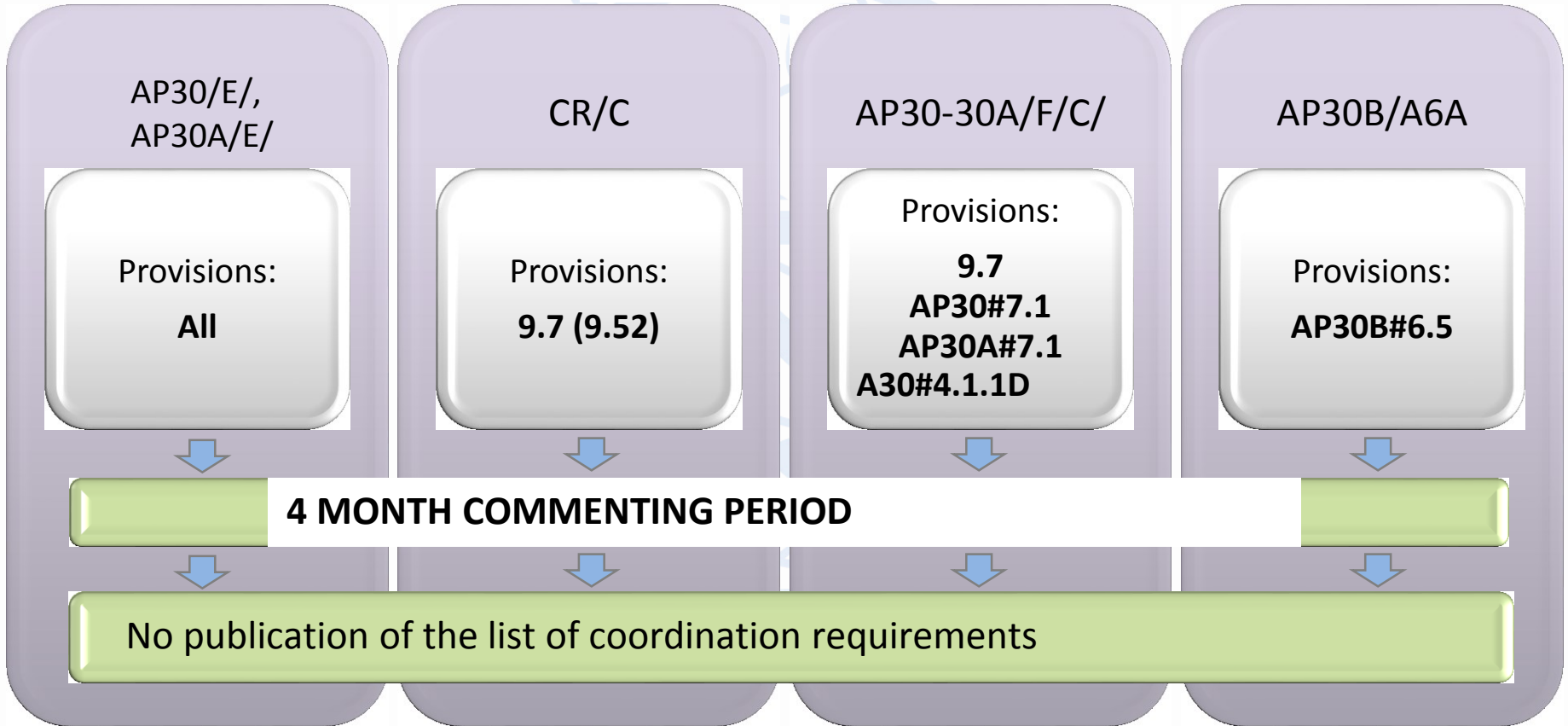
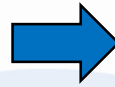

API not subject to coordination



- For frequency assignments for a satellite network or a satellite system not subject to the coordination procedure described in Section II of Article 9, No. **9.1** applies.
- 4 months commenting period (No.**9.3**)
- Res 55 -> comments to be submitted in electronic format using SpaceCom
- Publication of comments in API/B special section
- After at least 6 months after publication of API/A special section, may submit notification for recording in the Master Register.

Regulatory procedures for comments and resolution of difficulties

No.9.3 - No.9.4 of Article 9:

- Both administrations shall endeavor **to cooperate in joint efforts** to resolve any difficulties and shall **exchange any additional relevant information** that may be available
- *Either party can **request for the assistance of the Radiocommunication Bureau***
- In case of difficulties, the administration responsible for the **planned** satellite network shall **explore all possible means** to resolve the difficulties without considering the possibility of adjustment to networks of other administrations
- If no such means can be found, it **may request the other** administrations to **explore all possible means** to meet its requirements.
- The administrations concerned shall **make every possible effort** to resolve the difficulties by means of **mutually acceptable adjustments** to their networks.

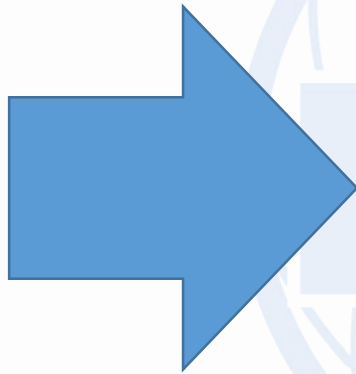

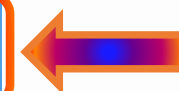

At Advance Publication stage, if, upon receipt of the BR IFIC containing API/A information for frequency bands which are not subject to Coordination procedure (see Sub-Section IA of Article 9 of the RR) published under No. 9.2B, according to the provisions of No. 9.3 any administration believes that interference which may be unacceptable may be caused to its existing or planned satellite networks or systems; its terrestrial services or wishes to have its territory excluded from the service area or for any other reason, it shall within four months of the date of publication of the BR IFIC communicate to the notifying administration (with a copy to the BR), its comments on the particulars.

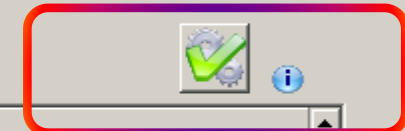

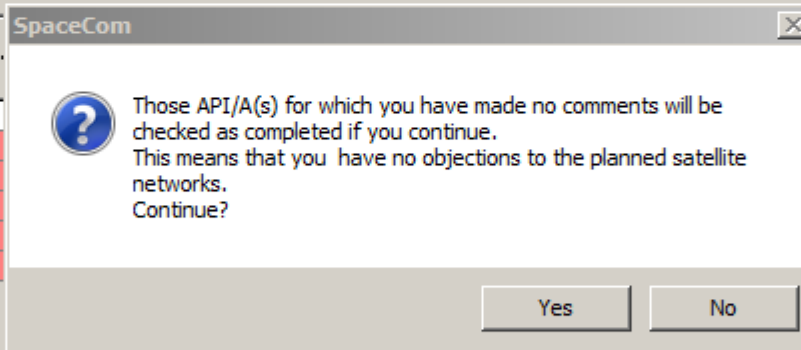
