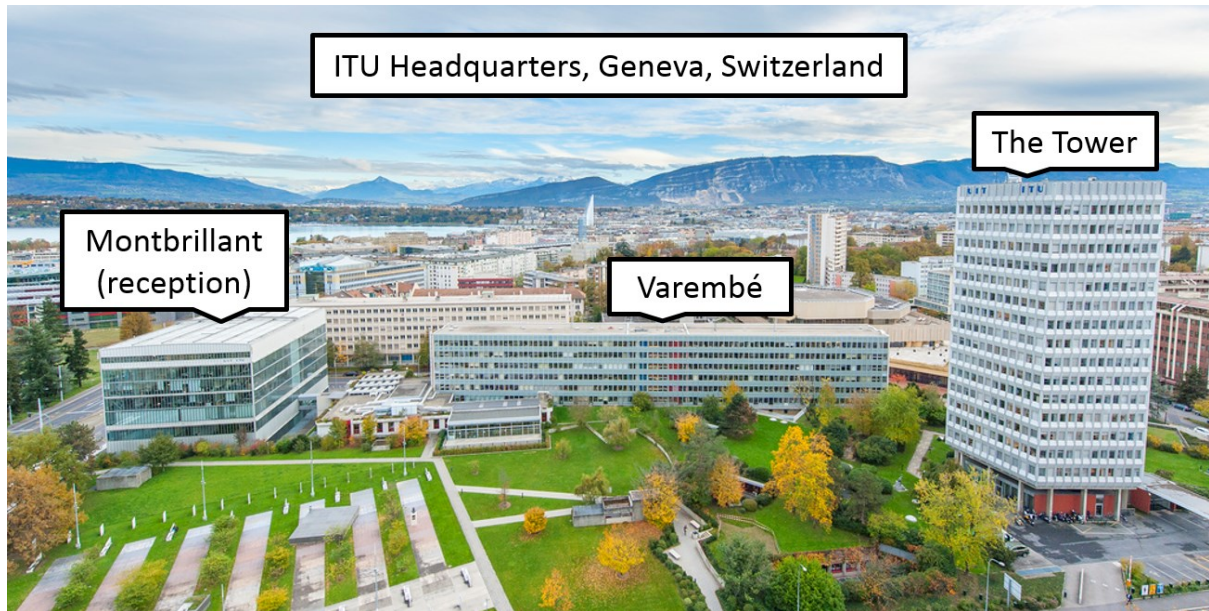


## ITU-T Newcomer Guide

Welcome to [ITU-T](#), where national governments, the private sector and academia work together to develop the telecommunication networks that connect the world. This guide will help you prepare for your first meeting at ITU Headquarters in Geneva, Switzerland.



### Getting started

A TIES account is essential in order to access meeting documents and services. If you do not already have one, we recommend that you [register for a TIES account online](#) as early as possible.

## Accessing documents and services

The study-group homepage provides access to International Standards (called Recommendations), formal meeting documents, reports, and other publications; and Electronic Working Methods services, including:

- **Mailing lists:** Subscribe to topics of interest, or catch up by browsing the archives.
- **Informal document sharing:** View and contribute to international standardization work.
- **Approval processes:** Monitor progress and have your say.
- **Databases:** Full access to draft/Approved standards, liaison activities, test signals and more.
- **Virtual meetings:** See below.

ITU-T is a Contribution-driven organization; Members are encouraged to submit proposals to a selected study group using the [Direct Document Posting mechanism](#). Submitters should ensure that all national or organizational procedures have been followed before uploading Contributions.

## Attending a meeting



The overall time plan for the meeting is published on the study-group homepage. To help with your orientation, we strongly encourage newcomers to attend the opening plenary meeting where the chairmen will introduce the study group and the organization of the meeting; and the interactive newcomer session, which is normally held on the first or second day of each study-group meeting.
