## HOW TO SIGN AND RATIFY this Convention

Proper **full powers** are required by all persons seeking to sign a treaty deposited with the Secretary-General of the United Nations or to make a reservation upon signature, except Heads of State or Government, or Ministers of Foreign Affairs.

#### Full powers should:

- bear the signature of the Head of State or Government, or the Minister of Foreign Affairs
- specify clearly the title of the instrument to be signed
- state the full name of the person authorized to sign the instrument concerned.

As already stated, **full powers** are not required where the Head State or Government or the Minister of Foreign Affairs signs in person. Furthermore, where general **full powers** have been issued to a person and have been deposited with the Secretariat in advance, specific **full powers** are not required.

It is advised that, whenever possible, **full powers** should be submitted for verification to the Treaty Section of the United Nations in advance of the intended date of signature.

#### Here is a sample of an instrument of **full powers**:

\* Subject to the provisions of the treaty, one of the following alternatives is to be chosen: **[subject to ratification]** or **[without reservation as to ratification]**.

Reservations made upon signature must be authorized by the full powers granted to the signatory.

## **The Tampere Convention**

Provides the legal framework for the use of telecommunications in international humanitarian assistance

**Puts in place a structure for managing requests for telecommunication assistance and for minimizing the impediments to that assistance before disasters occur** 

**Reduces regulatory barriers during disasters** 

Protects providers of telecommunication assistance while safeguarding the interests of the host country

The United Nations Secretary-General is the Depositary of the Convention.

The United Nations Emergency Relief Coordinator is the Operational Coordinator under the Convention, working closely with the International Telecommunication Union.



"Information on what has happened, how much damage there has been and what kind of help is needed, are key questions in disaster situations. To be able to answer them, we need a communications system that can be set up quickly and will guarantee a flow of information even when the local systems are inoperative. ### **OPINION OF THE CONFERENCE**

The Second Tampere Conference on Disaster Communications (CDC-2001), Tampere, Finland, 28-30 May 2001,

#### recognizing

the vital role of telecommunications in international humanitarian assistance,

#### concerned

that the magnitude, complexity, frequency and impact of disasters continue to increase at a dramatic rate, especially in the developing world,

#### acknowledging

the vital role of the Tampere Convention on the Provision of Telecommunications Resources for Disaster Mitigation and Relief Operations,

#### shares

the intent of ITU Resolution 36 (Rev. Minneapolis, 1998), which

#### "urges Member States

to work towards the earliest possible ratification, acceptance, approval or final signature of the Tampere Convention by the appropriate national authorities,

## further urges member States Parties to the Tampere Convention

to take all practical steps for the application of the Tampere Convention and to work closely with the operational coordinator ...",

#### appreciates

the role played by volunteers, in particular those of the Amateur Radio Service, and encourages administrations to facilitate their work in emergency telecommunications,

#### encourages

partnerships with the private sector and other non-State partners in securing the aims of the Tampere Convention,

#### invites

international and regional organizations to include in their agenda the application of the Tampere Convention by their member states,

#### invites

the ITU to study

- a) the use of public mobile networks for early warning and the dissemination of emergency information;
- b) operational aspects of emergency telecommunications such as call prioritization,

#### invites

the administrations and regional organizations, in their preparations for WRC-2003, to consider

- a) the recognized need of disaster relief organizations to use their existing radiocommunication equipment under disaster relief situations;
- b) the need to conclude frequency arrangements for such equipment in emergency situations;
- c) the possibility of designating the frequencies currently used by disaster relief organizations for non-critical purposes, which allow them to be utilized also for disaster relief in cases of emergency,

#### expresses

its gratitude to the Finnish Government for its continuous support of the Tampere Convention.
