❖ Tunis Agenda, paragraph 120

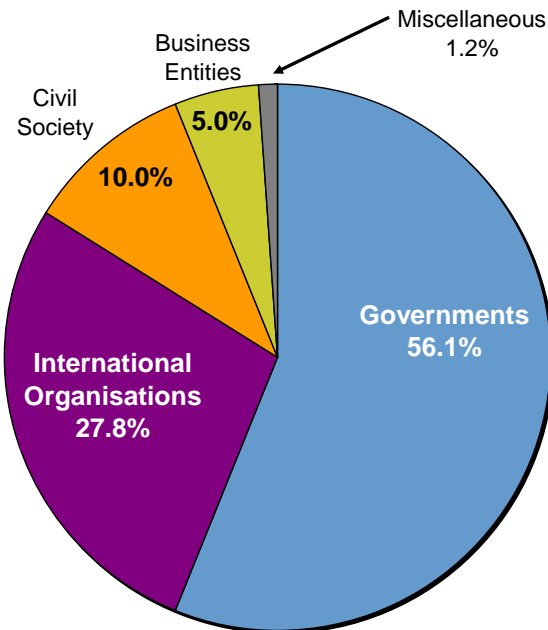

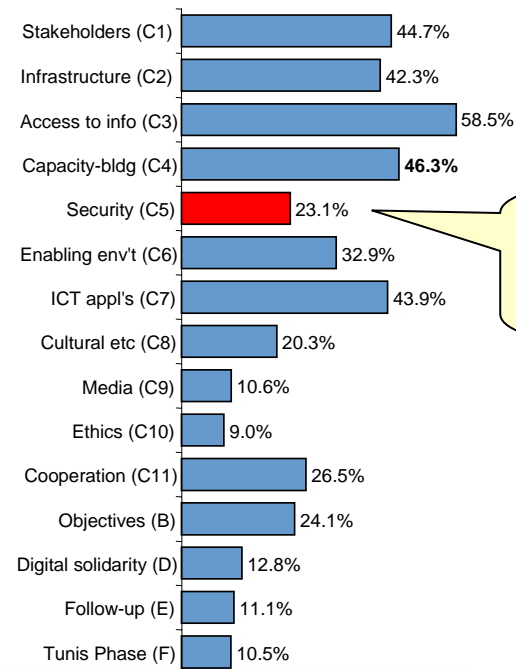

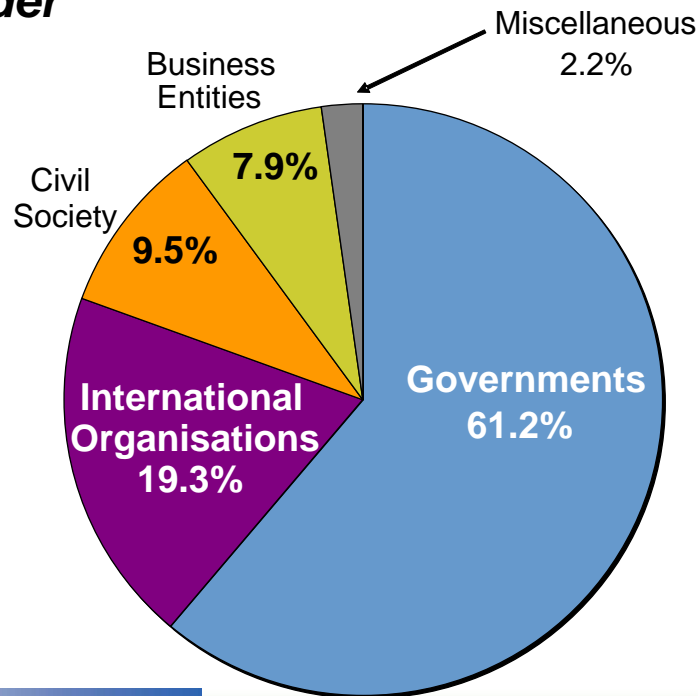

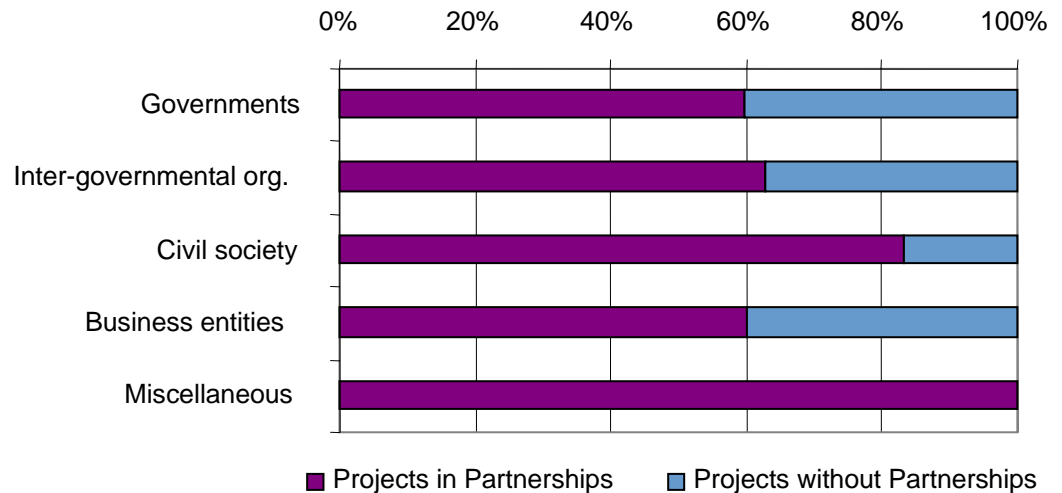

Selected Projects: *Governments*



- ❖ **Australia:** *E-Security National Agenda*
 - ❖ In November 2000, the scope of Australian Government's security policy was broadened to encompass a national approach to e-security.
- ❖ **Lithuania:** *Network and Information Security Portal*
 - ❖ On 7 February 2006 a new website www.esaugumas.lt ("e-security") was launched, aiming to provide a platform for gathering and spreading topical information on security issues.
- ❖ **Singapore:** *Infocomm Security Masterplan*¹¹³³
 - ❖ Around S\$38 million will be invested over three years (2005 to 2007) to implement the Infocomm Security Masterplan, which is a strategic roadmap that charts national efforts to develop capabilities to prevent cyber security incidents.¹⁵¹⁵



Selected Projects

International and Regional Organisations

- ❖ **Council of Europe: Convention on Cybercrime**
 - ❖ The Convention on Cybercrime and its Protocol is a binding international instrument available to fight cybercrime.
- ❖ **ITU: Partnerships for Global Cybersecurity**
 - ❖ ITU carries out various projects strengthening global cybersecurity including creation first global cybersecurity portal.
- ❖ **UNIDO: Building confidence and security in the use of ICTs**
 - ❖ UNIDO runs diverse projects on e-trust and e-security built into ICT programmes with focus on sharing of good practices for information security and trust, promotion of e-trade portals for secure trading of SMEs.

Selected Projects: *Business Sector*

- ❖ Internet Industry Association: *IIA Security Portal*
 - ❖ The IIA aims to build community confidence in using the internet for e-commerce by promoting in all users a 'culture of security'.
- ❖ Otto Mueller Consulting: *CYBER-IDENTITY UNIVERSE*
 - ❖ Cyber-Identity is the key to the further development of transactions in the electronic world in particular relevant for eGovernment, Records Management, RFID applications.
- ❖ Cisco Systems: *Cisco Networking Academies*
 - ❖ The Initiative has expanded to more than 50 Training Centers around the world. The web-based courses on network security, and wireless are available in nine languages.

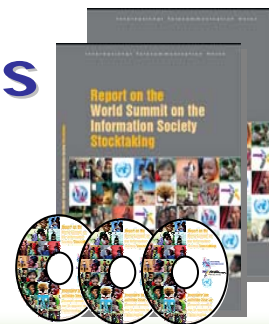


Selected Projects: *Civil Society*

- ❖ Privatera: *Training & Workshops on Security*
 - ❖ Privatera builds the capacity of NGOs and civil society organizations in the area of Information security, ICT risk awareness.
- ❖ Latin America Network of Protection of Information
 - ❖ A network was created as permanent forum to promote experience sharing and to establish channels for dialogue.
- ❖ Foundation InfoSurance: *PPP in field of Information Assurance*
 - ❖ InfoSurance focuses of the activities is Awareness, Prevention and Networking in Switzerland in the field of Information Assurance. InfoSurance sensitizes small and medium businesses to enhance their activities in IT-security.
