Popov (ONAT) is organizing a Regional Seminar on Telecommunications/ICTs Costs and Tariffs for CIS Countries, which will be held in Odessa, Ukraine from 24 to 26 October 2012.

This Seminar is intended for representatives from ministries, regulators, telecommunication operators, universities and other stakeholders of ITU Member States, Sector Members and Associates from the CIS Region.
