Dear Sir/Madam,

I recently had the pleasure to inform you that, at the kind invitation of the Government of Gabon, the International Telecommunication Union (ITU) Annual Forum on Telecommunication Regulation and Partnership in Africa (FTRA) will be held from 18 to 20 June 2012 in Libreville, Gabon.

The ITU has decided to capitalize on the event by having a back to back capacity building workshop on "Guidelines and Toolkit on Universal Service and Access" from 21 to 22 June 2012.

The objective of this workshop is to create awareness among participants of some of the pertinent issues on Universal Service and Access. The content of the workshop is based on the Guidelines and the Toolkit that have been developed by the ITU for SADC and CRASA under the aegis of the ITU-EC HIPSSA Project¹.

These Guidelines and Toolkit, which have been developed in the SADC region, were built on the experiences collected from the rest of Africa as well as from pertinent international best practices. They can be considered as "state of the art" and this workshop will be a unique opportunity to share these experiences.

The workshop is open to all ITU Member States, ITU Sector Members and Associates, and Regional Organizations on registration only. All discussions will be held in English and French with simultaneous
