MOTIVATION for application as Vice Chairman for Mobile Communications SG

During the last few years, with the downturn of the telecommunications industry, ITU-T has been in a transitional phase with more focus on finances and re-positioning itself in a world where there are many fora and SDOs.

The convergence between telecommunications, information technology, broadcasting and entertainment is continuing to drive the whole added-value chain and ITU-T, as a pre-eminent UN body needs to play a significant role in determining the global standards. These standards need to be open and non proprietary more than ever so as to remove market uncertainties, Technical-Barriers-to-Trade and create a large global market base to reduce costs.

I have served as Vice Chairman in SSG where I was also responsible for organising "seminars/workshops" and participating actively in them.

Standardisation is now a key element of strategic business planning. Kiritkumar P.
