Subject: **Girls in ICT Day Celebrations 28 April 2016**

Dear Sir/Madam,

International Girls in ICT Day is an initiative backed by ITU Member States in Plenipotentiary Resolution 70 (Rev. Busan, 2014) to create a global environment that empowers and encourages girls and young women to consider studies and careers in the growing field of information and communication technologies (ICTs). Resolution 70 calls for all ITU members to celebrate and commemorate International Girls in ICT Day on the fourth Thursday of April every year. This initiative also contributes to the achievement of the recently adopted Sustainable Development Goals (in particular targets 4.4, 5.b and 8.6) thus raising the importance of celebrating the initiative with inspiring events worldwide.

The current youth unemployment situation is severe and alarming, but the excellent job prospects provided by the ICT sector and the growing importance of digital skills to pursue successful professional careers across all sectors make ICTs a promising means to address the unemployment crisis. For this reason, it is important to raise awareness among girls and young women about these excellent job prospects, giving them the confidence to pursue ICT careers and inviting them to envision their future as ICT creators.

I would like to encourage all ITU Members to **organize Girls in ICT Day events this year on 28 April 2016** to introduce girls and young women to ICT careers, role models and to participate in hands-on ICT creation workshops, becoming part of this global campaign which to date has attracted over 177,000 girls and young women in 5,300 celebrations of International Girls in ICT Day in 150 countries worldwide.
