The <u>16th Global Symposium for Regulators (GSR-16)</u> is organized by the International Telecommunication Union (ITU), in collaboration with the Government of Egypt, from 11 to 14 May 2016 at the Maritim Jolie Ville International Congress Center, Sharm el-Sheikh, Egypt.

GSR brings together heads of national telecommunication/ICT regulatory authorities from around the world to share their views and experiences. The Symposium fosters a dynamic global dialogue among regulators, policy-makers, industry leaders and other key ICT stakeholders. This year, GSR will host a Thematic Pre-Conference for a <u>Global Dialogue on Digital Financial Inclusion</u> (11 May 2016) organized by the ITU Telecommunication Development Bureau (BDT), in collaboration with the Bill & Melinda Gates Foundation, the Alliance for Financial Inclusion (AFI), the Government of Egypt and other partners. This Pre-event is part of BDT's initiative to foster and strengthen collaborative regulation between telecommunication/ICT regulators and regulators from other sectors, focusing this year on the financial sector. It will bring together telecommunication/ICT and financial regulators from around the world to establish a constructive global dialogue on topical issues of relevance to stakeholders from all sectors.

The <u>6th Private Sector Chief Regulatory Officers (CRO) Meeting</u> will be held on 11 May after the Global Dialogue, as a GSR Pre-event. The CRO brings together senior industry regulatory officers who will focus on frameworks for greater collaboration between regulators and the private sector.
