We are pleased to announce that the 2018 edition of the annual *ITU World Telecommunication/ICT Regulatory Survey* conducted by the Telecommunication Development Bureau (BDT) of the International Telecommunication Union (ITU) is now available for completion by your Organization on ITU's online "ICTeye portal" at: <u>itu.int/icteye</u>.

The information gathered through this annual survey of regulatory policies and practices feed into a number of analytical publications on trends and challenges in the ICT sector as well as to support the work on designing tools and crafting best practices based on the rich and valuable experience of ITU Membership Administrations. The data gathered also allows us to keep current the data on ICT policy and regulation available on the ICTeye up-to-date.

Furthermore, we are pleased to inform you that based on the data submitted through this annual survey, we have developed the ICT Regulatory Tracker, an evidence-based tool to help decision-makers and regulators make sense of the rapid evolution of ICT regulation. The Tracker enables various analytical features to pinpoint the changes taking place in the CT regulatory environment. Using both quantitative and qualitative data, the Tracker makes possible benchmarking and the identification of trends in ICT legal and regulatory frameworks. It likewise helps identify the gaps in existing regulatory frameworks, making the case for further regulatory reform towards achieving a vibrant and inclusive ICT sector. The Tracker is composed of 50 indicators for a period of 10 years, from 2007 to 2016. It is available online at: <u>itu.int/go/tracker</u>. The 2017 edition will be launched at the 2018 ITU Global Symposium for Regulators (GSR) in July.
