**Subject: ITU Regional Development Forum for Africa, 18-20 July 2018, and Regional Spectrum Monitoring Workshop, 23 to 24 July 2018, Accra, Ghana**

Dear Sir/Madam,

I am pleased to invite you to participate in the International Telecommunication Union (ITU) Regional Development Forum (RDF) for the Africa region, from 18 to 20 July 2018, which will take place at the “Accra International Conference Centre”, Accra, Ghana. The Forum, focused on the theme “**ICT④SDGs: Towards the implementation of WTDC17 outcomes**”, is organized in partnership with the Ministry for Communications of Ghana. The Forum will be followed by a Regional Workshop on Spectrum Monitoring on 23 and 24 July 2018 at the same venue for radio communications experts who would also be able to attend RDF-AFR 2018.

Regional Development Forums provide an opportunity for high-level dialogue between the Telecommunication Development Bureau (BDT) and decision-makers of ITU Member States and Sector Members. They serve as a platform for assessing strategic orientation that may have an impact on BDT’s regional workplan in between World Telecommunication Development Conferences (WTDCs). In this context, these forums report on the activities of WTDCs, notably the Buenos Aires Action Plan (BaAP 2017), with particular emphasis on regional initiatives in order to get feedback from membership to adjust BDT’s work in each region of the world.

Established in 1865, ITU has reaffirmed its reputation worldwide as one of the most resilient and relevant organizations and it continues its work as the specialized agency of the United Nations for telecommunications and information and communication technologies. ITU is a unique neutral platform for organizations to network and collaborate with industry, governments, regulators and academia. ITU has a global membership of 193 Member States (Governments, administrators and regulators) and over 800 Sector Members from the information and communication technology (ICT) sector and more than 600 Members from academia.

The Regional Development Forum for Africa will discuss in detail the five regional initiatives approved by

WTDC-17, providing members with an opportunity to exchange experiences and best practices in their implementation of the said regional initiatives within the scope of the ITU rolling Strategic Plan for 2017-2020.

The Forum will be conducted in English and French, with simultaneous interpretation.
