New	Digital transformation for sustainable development including establishing data and	The Resolution emphasizing that digital transformation is inevitable in the short and medium term for developed countries, especially developing countries. Also emphasize on deployment of emerging technologies, including data centers and cloud computing of all kinds in developing countries, is a very important driver for digital transformation, as these structures will allow the spread of the digital economy

Thematic Priorities and Addis- Ababa Declaration



With Regards to the Thematic Priorities, Arab Preparatory Group For WTDC 21 suggested to have five Priority instead of four as followings:

- Connectivity;
- Digital Transformation;
- Enabling Environment;
- Resource Mobilization and International Cooperation;
- Building confidence, trust and security in the use of ICTs.

For the Addis -Ababa Declaration:

Arab Preparatory Group believes that the draft document may serve as the basis for further proposals and refinement by ITU Member States in preparation for the WTDC, where it will be finalized.



Arab Regional Initiatives



Arab Preparatory Group For WTDC 21 introduced five initiatives as following:

- Promoting digital transformation for a rapid transition to the digital economy and enabling to enable digital inclusion, especially for rapid response in the face of epidemics and emergencies; to enable digital transformation and developing digital services using telecommunications/information and communication technologies and by establishing an advanced infrastructure to support digital transformation,
- Enhancing trust, security and privacy in the use of telecommunications/ICTs in the era of new and emerging digital technologies; to Enhance confidence, security and privacy in the use of telecommunications/ICTs by supporting the deployment of resilient infrastructure and secure and reliable services that ensure the protection of privacy and personal data for all segments of society
- Develop digital infrastructure, promote universal access, and support smart cities and communities; Enhancing universal
 access to high-speed connectivity through the development of resilient and synergistic infrastructure and creating an enabling
 environment that ensures coverage everywhere and in a manner that ensures dealing with the requirements of new and
 emerging technologies
- Building capabilities, encouraging digital innovation, entrepreneurship and foreseeing the future; goal to raise awareness on a culture of digital innovation, future foresight and entrepreneurship for all segments of society
- **Developing digital and collaborative regulation and harmonizing ICT policy and regulatory frameworks;** To strengthening cooperation between regulators, policy makers in various sectors and other stakeholders in telecommunications/ICTs
