### Virtual TECH TALKS by the IAGDI-CRO

#### Background:

The Industry Advisory Group on Development Issues and Private Sector Chief Regulatory Officers (IAGDI-CRO) will organise two Tech Talks in February 2025, each aligned with the themes of ITU-D Study Group 1 and Study Group 2. These TECH TALKS aim to inspire forward-thinking discussions on cutting-edge digital trends and technologies that could shape future ITU-D work, including the development of new Study Group Questions to be adopted at WTDC-25.

#### Objectives:

The main objectives of these two TECH TALKS are:

- a) To bring industry perspectives to the forefront, highlighting **current and future complexities**, opportunities and challenges in the rapidly evolving technology landscape.
- b) To raise awareness of key technological trends and pressing topics related to digital development.
- c) To facilitate the **exchange of expert insights**, on future digital developments from the industry and private sector perspectives that are driving digital transformation today.

These discussions aim to foster stronger collaboration between ITU-D Sector Members, and ITU-D membership. By exploring cutting-edge digital trends and technologies, the TECH TALKS will encourage forward-thinking discussions that could shape ITU-D's future work and inspire potential Study Group Questions to be adopted at the WTDC-25.

#### Format and of TECH TALKS

Each virtual Tech Talk will be designed to cover themes along the scope of each ITU-D Study Group.

- Tech Talk on Digital Transformation

Each virtual Tech Talk will last 1 hour and 45 minutes and feature a selection of high-level visionary speakers from various industry segments of the ITU-D Sector Members.

The sessions will run as follows:

- Opening Remarks by the BDT Director
- Opening by the Chair of IAGDI-CRO
- High-Level segment with ITU-D Sector Members
- Open discussions

#### Output

A two-page report will be produced for each Tech Talk highlighting the main discussions and will be submitted as a contribution to the next meetings of both the ITU-D Study Groups and TDAG Working Group on the Future of Study Group Questions.
