Further to the circular letter [BDT/DDR/DER/DM/070](#)¹, I am pleased to invite you to the ITU's Global Youth Celebration, which will take place in Baku, Azerbaijan, on 16 November 2025, under the theme ***"Voices of Youth: Shaping the Digital Future."***

The Global Youth Celebration aims to recognize the dynamic role and energy that young people bring to the digital development sector by offering an engaging platform for dialogue and exchange between youth and key global technology stakeholders.

The event will feature intergenerational dialogues and incorporate interactive discussions, as well as networking opportunities for young people with decision-makers, policymakers, role models, and prominent stakeholders. Participants will also explore the challenges and opportunities of the digital age through practical experiences, including exclusive visits to Azerbaijan's most dynamic, cutting-edge technological sites.

The Global Youth Celebration will serve as a powerful and energizing space to elevate youth voices and spotlight their impact as catalysts of digital transformation. This celebration ultimately aims to amplify youth voices and their continued influence on ITU's work.

Participation is open to one (1) member per delegation, priority should be given to delegates under 35 years of age; Generation Connect Youth Envoys; and selected youth constituencies.

I take this opportunity to invite ITU Membership to kindly consider supporting the participation of their national Generation Connect Youth Envoys (GCYE) to be able to participate.
