Background

Artificial intelligence (AI) is transforming societies and reshaping children's lives in profound ways. While AI offers major opportunities to enhance children's learning, inclusion, safety, health and participation, it also presents significant risks—ranging from algorithmic bias and privacy violations to harmful content, child sexual exploitation and abuse, AI-generated exploitation materials, manipulation, and widening digital divides.

Despite rapid technological change, children's rights—enshrined in the Convention on the Rights of the Child (CRC) and its Optional Protocols—remain insufficiently integrated into global and national AI governance frameworks. AI systems, tools, and platforms are often not designed with children in mind, and there remains limited capacity across governments, industry, professionals, parents and other caregivers and children to understand and mitigate AI-related risks.

In response to this urgent need, the International Telecommunication Union (ITU), the UN Committee on the Rights of the Child (CRC) and UNICEF jointly led a year-long, multi-stakeholder drafting process to develop the Joint Statement on Artificial Intelligence and the Rights of the Child. Over 60 institutions—including UN agencies, governments, civil society, academic institutions, and major technology companies —contributed to the drafting. The voices of numerous children from all five regions of the United Nations were given due weight in the draft.

This Joint Statement represents the first international document dedicated specifically to child rights in the context of AI and establishes a unified global position on how AI must be designed, developed, deployed, and governed to respect, protect, and advance children's rights. It aligns with CRC General Comment No. 25 (2021) on children's rights in the digital environment and with ITU's Child Online Protection (COP) mandate under Resolutions 67 and 179.

Purpose of the Event

The side event will serve as the official launch and symbolic signing ceremony of the Joint Statement. It aims to:

- Publicly present the Joint Statement and its key recommendations.
- Showcase global multi-agency commitment to child-rights-based AI governance.
- Strengthen coordination among UN bodies, governments, private sector, civil society, and technical communities.
- Encourage Member States and partners to integrate child rights into AI policies, standards, and regulatory frameworks.

Key Areas covered in the Joint Statement

- Child-rights-based AI governance by States
- Child rights-based AI governance by UN bodies and other international and regional organizations in accordance with international law
- Responsibility, accountability and transparency
- Child safety
- Data protection and privacy
- Best interests of the child
- Non-discrimination and inclusion
- Child participation
- Al and the environment, including climate change
- Capacity building
- Education, science and awareness-raising

Expected Outcomes

The Joint Statement on Artificial Intelligence and the Rights of the Child is expected to contribute in:

- Increased global awareness and endorsement of child-rights-based AI governance.
- Stronger alignment among UN agencies, governments, industry, and civil society.
- Commitment to implement recommendations at national and institutional levels.
- Momentum for future collaboration, standards development, and practical support to Member States.
- Enhanced protection and empowerment of children in Al-driven digital environments.
