Background: Established under Resolution 71 (Rev. Kigali, 2022), the Industry Advisory Group on Development Issues and Private Sector Chief Regulatory Officers (IAGDI-CRO) meetings are a directive from the BDT Director to facilitate gatherings of high-level industry executives. The IAGDI-CRO, comprising ITU Development Sector (ITU-D) Sector Members, contributes by sharing expertise, aiding in the design and conceptualization of projects, and supporting resource mobilization for BDT implementation, among other activities.
