Subject: ITU Regional Workshop for the Arab States on promoting and measuring Universal and Meaningful Connectivity (UMC), 1-3 October 2024, Doha, Qatar

Dear Sir/Madam,

I am pleased to invite you to attend the ITU Regional Workshop for the Arab States on promoting and measuring Universal and Meaningful Connectivity (UMC), organized by the Telecommunication Development Bureau (BDT) of the International Telecommunication Union (ITU) in collaboration with the Communications Regulatory Authority (CRA) of the State of Qatar. This workshop will be held from **1 to 3 October 2024** in **Doha, Qatar**. The working language will be English and interpretation in Arabic and French will be provided for both on-site and remote participants.

This workshop is part of the three-year project “Promoting and Measuring Universal and Meaningful Connectivity” funded by the European Union and is intended for policymakers in charge of national policies and strategies for digital connectivity, and executives and experts responsible for the measurement of telecom/ICT development from ministries, national statistics offices (NSOs), regulators, telecom operators, research institutions, and other relevant organizations from the Arab States.

This regional workshop will cover the following topics:

- Embracing universal and meaningful connectivity: The new policy imperative (day 1)
- Data-driven decision making: Enhancing statistician-policymaker collaboration (day 2)
- Tracking UMC: Strategies for overcoming measurement challenges (day 3)

Participants from national statistical offices and other institutions that collect data on ICT are encouraged to complete two self-paced courses available through the ITU Academy: “[Measuring digital development: ICT access and use by households and individuals](#)” and “[Measuring digital development: Telecommunication / ICT indicators](#)”.

Registration for the workshop should be completed online through the following link: [here](#). Interested candidates must sign in using their existing ITU user account credentials, which include a username and

password. If they have previously created a user account for any recent ITU meeting, that account remains valid and can be used to register for this workshop. Candidates who do not have an ITU user account can create a new one by following the instructions available [here](#). There is no participation fee for this workshop. However, all expenses related to the travel, accommodation and insurance of participants should be covered by their Administration/Organization. Candidates who are selected but are not able to travel can also participate remotely, provided that they complete the online registration, and their application is accepted.

To encourage in-person participation from [developing countries](#), from low- and lower-middle income countries in particular, and subject to availability of funds and number of eligible applications received, up to two full fellowships may be granted per country. Full fellowships will cover the air ticket (one return economy class ticket by the most direct/economical route from the country of origin to the meeting venue), and appropriate daily subsistence allowance intended to cover accommodation, meals and incidental expenses.

To apply for fellowships, candidates must first register for the workshop and complete the two mandatory ITU Academy training courses, as explained above, and then complete the [fellowship application form](#) by **20 August 2024** at the latest. Selected fellowship applicants will be contacted separately with further instructions. A notification will also be sent to candidates who are not granted a fellowship.

In line with Plenipotentiary Resolution 213 (Dubai, 2018), the fellowship selection will consider gender balance and inclusion of persons with disabilities and with specific needs.

All participants will receive further guidance on preparing a short contribution to present during the sessions.
