It is my pleasure to invite your Administration/Organization to participate in the upcoming Regional Forum, **“Accessible Europe: ICT4ALL”**, to be held **on 2-3 December 2025 in Brussels, Belgium**. The Forum is organized by the **International Telecommunication Union (ITU)** and the **European Commission (EC)**, with the support of key European stakeholders.

Accessible Europe: ICT4ALL is a multistakeholder regional knowledge development forum held within the framework of the ITU Regional Initiative for Europe on “Digital inclusion and skills development”. In tandem with the International Day of Persons with Disabilities observed on December 3rd, this two-day event will leverage regional capacity on the topic of ICT accessibility and enable interactive discussions to share best practices. Special focus will be accorded to the intersection of innovation, inclusive design, and accessibility in the public and private sectors. Policy discussions will take place in light of the European Accessibility Act (EAA), which requires the member states to implement their transposed national laws by June 2025. The sessions are tailored to address Europe-specific challenges and opportunities aimed at fostering a digitally inclusive future.

The second day of Accessible Europe will highlight ICT innovations for accessibility. The Forum will feature a Pitching Competition on Digital Innovative Solutions for Accessible Europe. It will spotlight innovative European digital solutions dedicated to assisting persons with disabilities and enhancing accessibility. Attendees will have the opportunity to participate in a public vote to recognize the most impactful solutions presented. These sessions will bring together relevant stakeholders and provide a unique networking opportunity to foster collaboration in the digital accessibility field within the European region.
