Five (5) meetings of the TDAG Working Group on Streamlining Resolutions (TDAG-WG-SR) were held:

The first meeting of the TDAG-WG-SR took place online on 18 April 2024.

The Chair presented a <u>background paper</u>, the <u>proposed future meetings dates</u> and the <u>draft Terms of Reference</u>.

A <u>report on the first meeting of the TDAG-WG-SR</u> provides a summary of the discussions held.



The second meeting of the TDAG-WG-SR took place face-to-face and online on 21 May 2024 coinciding with the TDAG-24.

ATDI, France presented a Contribution on the "<u>Revision of Terms of Reference</u>" and the TDAG-WG-SR Chair presented a Contribution on the "<u>Draft Terms of Reference</u>".

At the TDAG-24, the <u>progress report on the work of the TDAG-WG-SR</u> was presented, the <u>TDAG-WG-SR Terms of Reference</u> was approved and two Vice-Chairs were appointed: Ms. Blanca Gonzalez (Spain) and Ms. Agustina Brizo (Argentina)



The third meeting of the TDAG-WG-SR took place online on 5 September 2024 and continued by correspondence until 23 November 2024.

United Kingdom presented a Contribution on "<u>Mapping towards Final Report</u>" and referred to a previous Contribution from the Russian Federation that had been presented at the TDAG-23 (<u>TDAG-23/31</u>). With this, the "<u>Proposed clustering of Resolutions</u>" Contribution from the TDAG-WG-SR Chair, was used as a means to seek volunteers to review clusters of WTDC resolutions.

A <u>report of the third meeting of the TDAG-WG-SR</u> provides a summary of the discussions.

The <u>TDAG-WG-SR Teams Collaborative Workspace</u> was used for work by correspondence.



The fourth meeting of the TDAG-WG-SR took place online on 5 December 2024.

Australia submitted a Contribution on a "<u>Draft review of WTDC Resolution 17 (Rev. Kigali,</u> 2022) - <u>Implementation of and cooperation on approved regional initiatives at the</u> <u>national, regional, interregional and global levels</u>" and Ghana submitted a Contribution on the "<u>Proposed Amendment of WTDC Resolution 22</u>".

A <u>report of the fourth meeting of the TDAG-WG-SR</u> provides a summary.

Kigali, 2022)", "Draft Resolution 24 (Rev. Kigali, 2022)", "Draft Resolution 58 (Rev. Kigali, 2022)", "Draft Resolution 1 (Rev. Kigali, 2022)", "Draft Resolution 31 (Rev. Kigali, 2022)" and "Draft Resolution 59 (Rev. Kigali, 2022)".
