Subject: Global Symposium for Regulators (GSR-26), 12-15 May 2026, Ankara, Türkiye

Dear Sir/Madam,

I am pleased to invite you to participate in the 2026 Global Symposium for Regulators (GSR-26) under the theme: *Navigating the Digital Frontier*. GSR-26 will be organized by the International Telecommunication Union (ITU), in collaboration with the Government of Türkiye. The event will be held from 12 to 15 May 2026 in Ankara, and will be chaired by Mr. Ömer Abdullah Karagözoglu, President of the Information and Communication Technologies Authority (BTK).

In line with the BAKU Declaration and the WTDC-25 Action Plan, and built around interactive high-level panels on topical and cutting-edge policy and regulatory issues, GSR-26 provides regulators and policy makers from around the world with a unique platform for discussions among peers and with other digital stakeholders. As part of GSR-26 pre-events, the Executive Heads of Regulators' Roundtable (upon invitation only), the Regional Regulatory Associations (RA)/Digital Regulation Network (DRN) meeting, and the Industry Advisory Group on Development Issues and Private Sector Chief Regulatory Officers' (IAGDI-CRO) meeting will be held on 13 May. In addition, a special Workshop on measuring the progress towards universal meaningful connectivity and an Executive level Masterclass: Beyond Connectivity: Modelling the Socio-Economic Future with Global Economic Model Study/Connectivity Planning Platform (GEMS/CPP), will take place on 12 May 2026. Core sessions of GSR-26 will be held from 13 May in the afternoon until 15 May (all day).

The proposed topics for the discussions consider suggestions by the membership following GSR-25. Focusing on navigating regulatory pathways towards a resilient and inclusive digital future, the sessions will address the following themes: anticipating, harnessing, experimenting, sharing, protecting and empowering, saving lives, addressing infrastructure, and unlocking investment. The GSR-26 consultation to identify Best Practice Guidelines on *Minimum Viable Governance for Digital* will follow shortly.
