الموضوع: الاستمارات المنقحة لتقديم بيانات البراءات وإعلانات الترخيص

تحتوي النشرة الإدارية CA/148 (15 أبريل 2005) على استمارات يستعملها الحائزون على البراءات الممنوحة أو مقدمو طلبات البراءات المعلقة من أجل تقديم بيانات البراءات إلى قطاع الاتصالات الراديوية في الاتحاد الدولي للاتصالات. وقد جرت مواءمة هذه الاستمارات مع الاستمارات المستعملة في قطاع تقييس الاتصالات. وقد أسفرت مباحثات التعاون اللاحقة مع المنظمة الدولية للتوحيد القياسي (ISO) واللجنة الكهرتقنية الدولية (IEC) عن استمارات منقحة حديثاً متواءمة بين الكيانات الأربعة المذكورة جميعها. وتحل الاستمارات الجديدة، الملحقة بهذه النشرة، محل تلك الواردة سابقاً في النشرة الإدارية CA/148 المؤرخة 15 أبريل 2005، وينبغي استعمالها اعتباراً من 30 سبتمبر 2006.

ونرجو ملاحظة أنه ليس من الضروري إعادة تقديم معطيات سبق حفظها في قاعدة معطيات بيانات البراءات. إذ ينبغي استعمال الاستمارات الموحدة الجديدة في حالة بيانات البراءات الجديدة فقط.
