Addendum 1 to Administrative Circular CA/196 10 December 2011

To Administrations of Member States/Observers of the ITU

Subject: World Radiocommunication Conference 2012 (WRC-12)

As announced by the Secretary-General in Circular Letters Nos. 11 and DM-11/1000 of 10 March 2011, the World Radiocommunication Conference 2012 (WRC-12) will be held from 23 January to 17 February 2012, immediately following the Radiocommunication Assembly 2012 (RA-12). Radiocommunication Bureau Administrative Circular CA/196 of 6 April 2011 provided further details for WRC-12 to assist participants with their preparations. The purpose of this addendum is to provide additional details on WRC-12 preparations.

2 Submission of proposals prepared in advance of WRC-12

Member States are kindly reminded to refer to Section 3 and Annex 2 of CA/196 for the submission of their proposals for the work of WRC-12. In particular, in order to ensure, in accordance with Resolution 165 (Guadalajara, 2010), the timely translation and thorough consideration by delegations of documents submitted to WRC-12. Member States should submit their proposals no later than 14 days before the commencement of the Conference, i.e. 9 January 2012.

3 WRC-12 Proposals Management System

A Proposal Management System has been developed for WRC-12 to provide an easy-to-use web access to the proposals for the work of the Conference. It is available on the WRC-12 webpage (http://www.itu.int/ITU-R/go/wrc-12, click on "Documents" and find "WRC-12 Proposal Management").

Initial information regarding the availability of WRC-12 documents was provided in Sections 4 and 5 of CA/196.
