Subject: First meeting of the Working Party of the Special Committee on Regulatory/Procedural matters in preparation for the WRC-07

Introduction

Following the WRC-03 decisions and in accordance with the work programme of the Conference Preparatory Meeting (CPM 06-1), established in July 2003 it was agreed, that the Working Party of the Special Committee (WP-SC) will hold two meetings, namely, in the second part of 2004 and in the second part of 2005.

The first meeting will be held in Geneva, from 22 to 27 October 2004 at the ITU premises. The delegate registration, document distribution and other related services will be located in the vicinity of the meeting rooms. The opening session will take place at 10:00 hours and registration of delegates will start at 08:30 hours on 22 October 2004.

Programme of the meeting

Contributions in response to the WP-SC draft agenda (Annex 1) are invited. See also Resolution ITU-R 38-3, Resolution 802 (WRC-03) and the list of items considered by CPM 06-1 for primary consideration by the special committee for WRC-07 Preparation (see Annexes 2, 3 and 4). The Working Group will conduct its work in English.

Visa requirements

Any such request must specify the name and functions of the individual(s) for whom the visa(s) is/are requested and be accompanied by a copy of the approved registration form approved for the ITU conference or meeting in question.
