By Administrative Circular CAR/242 dated 4 June 2007, 4 draft revised Recommendations and 1 draft new Recommendation were submitted for simultaneous adoption and approval by correspondence (PSAA), following the procedure of Resolution ITU-R 1-4 (§ 10.3).

The conditions governing this procedure were met on 4 September 2007, with seven Administrations responding in favour of the adoption and approval of the Recommendations. These Administrations were also in favour of the suppression of the 2 Recommendations.

The approved Recommendations will be published by the ITU and Annex 1 to this Circular provides their titles, with the assigned numbers. Annex 2 provides the list of suppressed Recommendations.
