By Administrative Circular CACE/766 dated 29 February 2016, 2 draft new ITU-R Recommendations and 1 draft revised ITU-R Recommendation were submitted for simultaneous adoption and approval by correspondence (PSAA), following the procedure of Resolution ITU-R 1-7 (§ A2.6.2.4). In addition, the Study Group proposed the suppression of 1 ITU-R Recommendation.
