Subject: Radiocommunication Study Group 6 (Broadcasting service)

- Adoption of 1 new ITU-R Recommendation and 2 revised ITU-R Recommendations and their simultaneous approval by correspondence in accordance with § A2.6.2.4 of Resolution ITU-R 1-7 (Procedure for the simultaneous adoption and approval by correspondence)
- Suppression of 2 ITU-R Recommendations

By Administrative Circular CACE/789 dated 23 November 2016, 1 draft new ITU-R Recommendation and 2 draft revised ITU-R Recommendations were submitted for simultaneous adoption and approval by correspondence (PSAA), following the procedure of Resolution ITU-R 1-7 (§ A2.6.2.4). In addition, the Study Group proposed the suppression of 2 ITU-R Recommendations.

The conditions governing this procedure were met on 23 January 2017.
