Subject: Radiocommunication Study Group 6 (Broadcasting service)

 Proposed adoption by correspondence of 1 draft revised ITU-R Recommendation

At the meeting of Radiocommunication Study Group 6, held on 26 July 2016, the Study Group decided to seek adoption of 1 draft revised ITU-R Recommendation in accordance with § A2.6.2.2.3 of Resolution ITU-R 1-7 (Adoption by a Study Group by correspondence). The title and summary of the draft Recommendation are given in the Annex to this letter.

The consideration period shall extend for two months ending on <u>9 October 2019</u>. If within this period no objections are received from Member States, the approval by consultation procedure of § A2.6.2.3 of Resolution ITU-R 1-7 will be initiated.

Any Member State who objects to the adoption of the draft Recommendation is requested to inform the Director and the Chairman of the Study Group of the reasons for the objection.

Any ITU member organization aware of a patent held by itself or others which may fully or partly cover elements of the draft Recommendation mentioned in this letter is requested to disclose such information to the Secretariat as soon as possible. Draft revision of Recommendation ITU-R BT.1877-1

Error-correction, data framing, modulation and emission methods for second generation of digital terrestrial television broadcasting systems

The proposed revisions include:
