Subject: Proposed simultaneous adoption and approval by correspondence of 23 draft revised and 1 draft new Recommendation developed by Radiocommunication Study Group 3

At its meeting, held on 28 and 29 October 2004, Radiocommunication Study Group 3 decided to seek adoption of 23 draft revised Recommendations and 1 draft new Recommendation by correspondence (§ 10.2.3 of Resolution ITU-R 1-4) and further decided to apply the procedure for simultaneous adoption and approval by correspondence (PSAA). In accordance with the interim procedures recommended by the RAG at its meeting in November 2004*, the draft Recommendations in English, as revised at the meeting of Study Group 3, are enclosed with this letter.

The consideration period shall extend for 3 months, ending on 8 March 2005. If within this period no objections are received from Member States, the draft Recommendations shall be considered adopted by Study Group 3. Furthermore, since the PSAA procedure has been followed, the draft Recommendations shall also be considered as approved. However, if any objection is received from a Member State during the consideration period, the procedures given in § 10.2.1.2 of Resolution ITU-R 1-4 shall apply.

After the above-mentioned deadline, the results of the PSAA procedure shall be announced by circular letter (CACE) and the approved Recommendations published as soon as practicable.
