Subject: Application of **Nos.11.44/11.44.1** of the Radio Regulations and *resolves 1* of Resolution **49**

(Rev.WRC-03) to satellite networks with the 7-year expiry date for notification between 1 January

and 30 June 2006

Date:

- 1. The Radiocommunication Bureau hereby draws the attention of all administrations to the provisions of **Nos. 11.44** and **11.44.1** of the Radio Regulations and the related Rules of Procedure as well as to *resolves 1* of Resolution **49 (Rev. WRC-03)**.
- 2. These provisions stipulate that the assignments included in a request for coordination shall no longer be taken into account by the Bureau or administrations unless, by the end of the seven-year regulatory period as from the date of receipt of the relevant advance publication information (API), for APIs received as from 22 November 1997:
 - the assignments in question have been brought into use,
 - the complete first notice for recording of these assignments under No. 11.15 has been received by the Bureau, and
 - the complete "due diligence" information submitted in accordance with Resolution 49 (Rev.WRC0-03) has been received by the Bureau.
- 3. In this context, the Bureau has prepared two lists of networks with an indication of their respective API date of receipt and seven-year regulatory period expiry date, which falls between 1 January and 30 June 2006, as follows:
 - 3.1 Annex 1 contains the list of networks for which <u>no notification information seems to have yet been</u>
 <u>received</u> by the Bureau, with an indication where the Bureau does not seem to have yet received the "due diligence" information;
 - 3.2 Annex 2 contains the list of networks for which notification information, having been received:
 - a) is under examination, or
 - b) was returned to the administration as the result of an unfavourable finding, or
 - c) was recorded in the MIFR as the result of a favourable finding.

Annex 2 contains also an indication where the Bureau does not seem to have yet received the "due diligence" information for those networks.

- 4. The Bureau requests your Administration to kindly verify the attached lists and submit the notification information under No. 11.15 before the indicated expiry of the 7-year period, either with all the required agreements obtained (No. 11.32), or with a <u>statement that some coordination could not be successfully completed</u> and with a request to apply the provisions of Nos. 11.32A, 11.35 or 11.41, as appropriate, with respect to certain missing agreements.
- 5. With respect to the notification information received and considered under a), b) or c) of paragraph 3.2) above, similar or additional notification information may still be submitted before the indicated expiry of the 7-year period, in order to cover all the frequency assignments included in the request(s) for coordination or for advance publication information, according to the case.
- 6. Your Administration is also kindly requested to check further whether any of its networks, not listed in the Annexes, also fall into the above category and, if so, to submit the notification information as mentioned in paragraph 4 above for the corresponding assignments still at the coordination stage or published as an advance publication information, according to the case, and for which the seven-year regulatory period will expire between 1 January and 30 June 2006.
- 7. The attention of your Administration is also drawn to the fact that, for the networks identified with an "X" in the Annexes, the Bureau does not seem to have received the "due diligence" information, which, for networks subject to *resolves 1* and §1 of Annex 1 to Resolution 49 (Rev.WRC-03), is to be provided before the expiry of the seven-year regulatory period referred to above.
- 8. For networks for which the "due diligence" information has already been received, your Administration is also kindly requested to check whether its networks contain frequency assignments in frequency bands not covered by that "due diligence" information and, if so, to submit the complete "due diligence" information before the expiry of the same seven-year regulatory period.
- 9. Please note that this communication is to be considered as the Bureau's advance notice referred to in Nos. 11.44/11.44.1 and in § 10 of Annex 1 to Resolution 49 (Rev.WRC-03).
- 10. The Bureau trusts that your Administration will provide the required information as indicated above. In the event that the assignments are not brought into use and the notification information as well as the "due diligence" information are not received by the Bureau within the specified period, the Bureau will initiate the cancellation of the relevant assignments as foreseen by Nos. 11.44/11.44.1 and the related Rules of Procedure and/or Resolution 49 (Rev.WRC-03), according to the case.
