Subject: Radiocommunication Study Group 1

- **Proposed adoption by correspondence of 7 draft new Recommendations and 4 draft revised Recommendations**
- **Proposed suppression of 1 Recommendation**

At the meeting of Radiocommunication Study Group 1, held on 24 and 25 October 2005, the Study Group decided to seek adoption of 7 draft new Recommendations and 4 draft revised Recommendations according to § 10.2.3 of Resolution ITU-R 1-4 (Adoption by a Study Group by correspondence). The Study Group also proposed the suppression of 1 Recommendation (ITU-R SM.669-1). In accordance with the interim procedures recommended by the RAG at its meeting in November 2004*, the draft Recommendations in English, as revised at the meeting of Radiocommunication Study Group 1, are enclosed with this letter.

The consideration period shall extend for two months ending on 24 January 2006. If no objections are received from Member States during this period, the approval by consultation procedure of § 10.4.5 of Resolution ITU-R 1-4 will be initiated. However, any Member State who objects to the continuation of the approval procedure for the draft Recommendation is requested to advise the Director of the reason and to indicate possible changes to the text in order to resolve the problem.
