## To Administrations of Member States of the ITU and Radiocommunication Sector Members participating in the work of Radiocommunication Study Group 6

## Subject: Radiocommunication Study Group 6

Proposed adoption by correspondence of 4 draft new Recommendations and 9 draft revised Recommendations

At the meeting of Radiocommunication Study Group 6, held on 7 and 8 May 2007, the Study Group decided to seek adoption of 4 draft new Recommendations and 9 draft revised Recommendations according to § 10.2.3 of Resolution ITU-R 1-4 (Adoption by a Study Group by correspondence). In accordance with the interim procedures recommended by the RAG at its meeting in November 2004<sup>\*</sup>, the draft Recommendations in English, as revised at the meeting of Radiocommunication Study Group 6, are enclosed with this letter.

The consideration period shall extend for two months ending on <u>29 August 2007</u>. If no objections are received from Member States during this period, the approval by consultation procedure of § 10.4.5 of Resolution ITU-R 1-4 will be initiated. However, any Member State who objects to the continuation of the approval procedure for a draft Recommendation is requested to advise the Director of the reason and to indicate possible changes to the text in order to resolve the problem.
